Minutes of Arts and Culture Advisory Committee

Cultural Infrastructure

- > Presentation by Bill Royal, Team Leader Urban Design, Ku-ring-gai Council.
- Cultural Infrastructure PowerPoint Presentation to be circulated to members. The following points were highlighted in the presentation and discussion:
 - Council's role is to provide facilities program and services, encourage the professional creative sector, support local cultural organisations.

- Ku-ring-gai LGA is dominated by creative and cultural consumers with 46% of the population participating in cultural activities and 28% volunteering.
- Wellbeing, resulting from community cultural experience, is one of the most important outcomes
- Upgrading deteriorating existing facilities is a priority.
- After Covid, local venues have become less amenable for external users to hire/use.
- There are a number of potentially untapped local venues including public schools (NSW Public Infrastructure team), private schools such as Knox, St Ives Showground renovated pavilions, Cerebral Palsy Alliance venue in St Ives, national parks and crown lands.
- The committee members desire to communicate a collective message, see Proposed Action Items.

Cultural and Creative Register research presentation and discussion Facilitated by

- 4. Review structure and Terms of Reference for the Arts and Cultural Advisory Committee to include 20 members, the ability to deputise members and recruit up to 10 reserves.
- 5. Presentations on the Member Survey and the Cultural and Creative Register to be deferred for consideration at a later meeting.
