- Α. That the Ku-ring-gai Planning Panel adopts the revised draft Ku-ring-gai Local Environmental Plan (Town Centres) 2008 as it applies to the Ku-ring-gai Centres attached to the report including amendments as outlined in the report.
- В. That the Ku-ring-gai Planning Panel submit a copy of the revised draft Ku-ring-gai Local Environmental Plan (Town Centres) 2008 to the Minister for Planning in accordance with section 69 of the Environmental Planning and Assessment Act 1979, requesting that the Plan be made.
- C. That in accordance with Section 70(1A) of the Environmental Planning and Assessment Act, 1979 and consistent with the Director General's letter of 12 August 2008 providing the Planning Panel with written authorisation to exercise delegation, the Minister for Planning be requested to include reference to the listing of the "Ku-ring-gai sites" as appearing in Schedule 2 Part 3A projects – specified sites of State Environmental Planning Policy (Major Projects J 2005 (the Major Projects SEPP) in Clause 1.9(2) of the written instrument, thereby displacing the Major Projects SEPP as it applies to the "Ku-ring-gai sites".
- D. That the Planning Panel request that the Minister for Planning amend the draft Local Environmental Plan under section 70 (IA) of the Environmental Planning and Assessment Act 1979, by inserting the same clause as Clause 1.9A in the

- Liverpool 2008 Suspension of Covenants, Agreements and Instruments into the draft Ku-ring-gai Local Environmental Plan (Town Centres) 2008.
- E. That delegation be granted to the General Manager, Ku-ring-gai Council, in consultation with the Chair of the Ku-ring-gai Planning Panel, to make all necessary corrections and amendments to the revised draft *Ku-ring-gai Local Environmental Plan (Town Centres) 2008* for drafting inconsistencies, or minor amendments as necessary to ensure consistency with NSW Standard Order Template and Department of Planning policy.
- F. That the Ku-ring-gai Planning Panel refers the additional potential heritage items identified by Paul Davies Pty Ltd in their Ku-ring-gai Town Centres Heritage Conservation Area Review to Ku-ring-gai Council for consideration in the preparation of the comprehensive Ku-ring-gai Local Environmental Plan.
- G. That the Ku-ring-gai Planning Panel refers the recommendations contained in the report relating to development control plan matters to Ku-ring-gai Council for consideration in the preparation of the Ku-ring-gai Town Centres Development Control Plan.
