1. The bin shall remain the property of Ku-ring-gai Council. **In the event of the owner/occupier moving, the bin must remain at the address nominated on this form.**
2. The bin will be serviced on the normal collection day. Council will collect the 240L bin and replace it with a 120L bin.
3. PLEASE LEAVE THE 240L BIN AT THE FRONT OF THE PROPERTY FOR COLLECTION. THE COUNCIL WILL TRANSFER WASTE TO THE NEW BIN.
4. Maintenance including repairs and parts replacement will be provided by Council, however reasonable care of the bin shall be taken by the resident.
5. A reduction in charge will be levied on a pro-rata basis from the commencement date of the reduced service.
6. The service charge will revert to the standard charge for the **[24/25 financial year]** pro rata.
7. If you are not the owner of the property please have the owner or agent request the service on your behalf.
8. The service agreement will not commence until Council has received the signed agreement form.
